2) SUBMIT PROOF OF YOUR IDENTITY
a) Nationals born in Trinidad and Tobago
If you were born in Trinidad and Tobago, you must provide the following ORIGINAL documents as evidence of identity:
- Children: Birth Certificate - Computer generated with pin number
- Children of Trinidadian mothers: Civil Applications or Court Orders (where applicable)
- All other persons: Certificate of Birth or Identity - you must produce the identity certificate of that country. The Certificate of Birth and Tobago Citizenship Certificate (where necessary). If you do not have that certificate, all other documents which may be used to establish your identity will be accepted.
b) Nationals born outside of Trinidad and Tobago
If you were born outside of Trinidad and Tobago and are a citizen, you must also submit original documents in support of your citizenship.

3) Submit: Birth Certificate or Birth Record with parent's names
4) Proof of parent's: Trinidad and Tobago identity (Two Birth Certificates, Marriage Certificate and Trinidadian Passport where applicable)

5) Other documents: Certificate of Registration, Birth Certificate, Affidavits, Certificate of Naturalization, Birth Certificate, Certificate of Adoption, Non-Territory Affidavit, Birth Certificate where possible.

Immigrant visa holders must be related to a U.S. citizen or permanent resident.
